Driver Education/Training to be conducted in the State of Ohio, Butler & Hamilton Counties and students must be 15 years, 5 months old to enroll. Student's date of birth is: _____

The driving school shall furnish a Licensed Instructor/Trainer for instruction and training. The driving school does not guarantee the issuance of a Driver's License to any student. Students under the age of 18 years of age will be issued a State of Ohio Certificate of Completion upon completion of the 32 hour course to qualify for the Basic Operator's Skill Test.

Students who fail to cancel a Behind-the-Wheel appointment 72 hours in advance will be charged \$40.00 for a Broken Appointment (NO SHOW) unless another student can be found to take said time. We ask that students be at the point of pick-up 15 minutes *before* the designated time. If it becomes necessary to implement a cancellation fee, ALL future behind-the-wheel sessions will be cancelled until the fee is satisfied. The parent/legal guardian or the person having custody, and the student are jointly liable to this AGREEMENT/CONTRACT. The school will not refund any tuition or part thereof as long as *drive-rite* School, LLC. (faoh) is ready, willing and able to fulfill its part of the AGREEMENT.

Students should arrive/be ready for classroom/behind-the-wheel sessions 15 minutes *before* the scheduled start time. Late students will not be admitted into the class or behind-the-wheel session. Students are responsible for their behavior in the classroom and vehicle. At the discretion of the instructor/trainer, students displaying unruly, disruptive, destructive, disobedient behavior, or failing to participate when called upon or sleeping in class shall be dismissed from that class/vehicle session. Students asked to leave a class or behind-the-wheel session by the instructor/trainer at any point will be required to repeat that whole class or in-car session and be required to pay an additional class or in-car fee.

In order for a student to schedule behind-the-wheel sessions, their file MUST be complete. This includes completion a minimum of 24 clock hours of classroom education as indicated on the Classroom Training Form, with a minimum average score of 75% on State Tests and ALL forms signed and in their file (Agreement/Contract, Notes & Policies, Code of Conduct, Medical Release Form and Valid copy of the Temporary Permit) or Behind-the-Wheel Training shall be denied.

The projected date a student will complete this course/program is within 60-90 days of beginning the classroom unless other arrangements have been made between a parent, legal guardian, or person legally responsible for that student and the *drive-rite* School.

Full course of 32 hours (Classroom and Behind-the-Wheel) will cost \$415.00 (Gold Package) and will consist of 24 hours of classroom, 8 hours of Behind-the-Wheel based upon the "Ohio Driver Training Curriculum" prepared August, 2002. Payment shall be made (IN FULL) at the time of registration.

*Split payments can be made with a \$207.00 on the day of Registration, the remaining balance on the 5th SCHEDULED Class day. Failure to pay on time or if a balance remains 14 days after classroom completion an assessment of a 1.50%, of the remaining balance shall be applied to the student's account per month until satisfied and behind-the-wheel selection shall be denied.

**Students MUST complete the entire course/program within 6 months from the date of signature of the Agreement. Failure to do so may result in a classer-enrollment fee and taking a test of knowledge gained during the classroom portion of the education. If a student does not score a minimum of 75% on said test, they may return to the classroom resulting in additional fees of \$ 15.00 per classroom session.

Optional Services & Fees:

- Additional 60 minutes of In-Car Training: \$55.00 per event
- Use of *drive-rite* vehicle for Licensing Exam:* \$60.00 meeting at the Testing Station or \$50.00 per hour with review
- Fuel Surcharge: \$20.00 charged for behind-the-wheel training when fuel exceeds \$4.00 per gallon based on regular unleaded fuel at Speedway, Nilles & Dixie Highway.
- Lost Certificate: \$15.00
- Non-Sufficient Funds Fee: \$50.00
- Class Re-Enrollment Fee: \$100.00 if a student does not complete within 6 months (per St. Of OH Admin. Code)
